## Information bulletin for migrants in Geneva

## Primary school: registration

Any child living in Geneva, regardless of his/her legal status, has the right and the obligation to go to school. This year, **children born before 01.08.2016** start school on **August 24**th **2020**. Registration dates are Friday 28 February from 4.30 to 7.30 pm, and Saturday 29 February from 9 to 11 am. If you haven't received the notification, you should contact the school closest to your home to announce yourself.

To be accepted at school, your child must have health insurance. CCSI is in charge of affiliation for children without a residence permit. Make an appointment, and come with the official identification for the child and his/her legal guardian, as well as your address. Your child will be able to start school as soon as you have come to CCSI.

#### Information sessions

CCSI organizes collective information sessions, in various languages, on issues like education, housing, social insurances, etc. To find out when the next session is, please check our website (www.ccsi.ch) or look at the screens in the waiting area at CCSI. ### Parascolaire and school meals for children

Depending on your income, you could benefit from **free** parasco-laire (afterschool) activities, re-gardless of where you live in Geneva. CCSI can help you with the application but caution, the request must be renewed each year and must be done before November.

### 2020-2021 registration

Registration for *parascolaire* and school meals takes place at the same time, in the same place, in May 2020. You will receive the information through the school. DO NOT MISS THESE DATES – or your child will not be able to attend when school starts! Addresses and times for registration can be found at <a href="https://www.giap.ch">www.giap.ch</a> as of April.

If you live in the city of Geneva and your income is within the range, CCSI can request **free school meals** for your child. Please come with a copy of the health insurance subsidy certificate and valid passports. For residents of other municipalities, please ask CCSI if financial aid is available.

<u>Caution</u>, you must always pay the fixed fees (*cotisation*), and the meals your child didn't attend without a valid excuse.

The request for free school meals must be submitted **by 15 July 2020** for the 2019-2020 school year.

# Working declared and taxed at source: what is the difference?

Every job in Switzerland must in principle be declared to social insurances. It Is possible to be declared to social insurances even if you don't have a residency permit. It is your employer's responsibility to declare you. Once you are declared, your employer will withhold a part of your gross salary to pay your dues to social insurances such as: AVS, AI, APG, CI, etc. After these social dues have been withdrawn, you receive your net salary (= takehome pay).

Being taxed at source ("imposé à la source") is compulsory for persons with a residency permit (B or L permit) who work declared. Your employer must declare you to the tax authorities and set aside a portion of your salary to pay the tax. The amount set aside for the tax will depend on your personal situation (married or not, with or without children and/or dependents, singleparent family, etc.). Paying taxes allows you to access various services such as the health insurance subsidy, subsidized housing, etc. Your employer can declare you to the tax authorities even if you don't yet have a residency permit.

### Health insurance subsidy

You must request the subsidy (financial aid from the State for health insurance) for your child's health insurance each year by 30 November. If you haven't done so yet, please make an appointment with CCSI and bring the 2020 insurance policy with you. This year, you need to provide the following documents:

- a) If you have family benefits (allocations familiales), you need to bring a statement of the sums you received in 2019.
- b) If you (as an adult) have health insurance, please bring your 2020 insurance policy/ies.
- c) Please bring your bus passes.

If you have a permit or are taxed at source (directly deducted from your salary), other documents are requested. Please ask the reception what to bring to the appointment.

As soon as you receive the subsidy, please bring a copy of the certificate to our reception with your name and phone number.

The subsidy is a right based on your income. Requesting it will not affect other proceedings, such as the request for a residency permit. Only children residing in the canton of Geneva have the right to the health insurance subsidy. CCSI cannot request the subsidy for children living in neighboring France.

The subsidy covers your child's premium up to 101.- maximum. Every month, you will have to pay whatever exceeds 101.-. If you have supplemental health insurance, you will have to pay for it entirely; it is never covered by the subsidy.

It often takes time for the insurance company to register your subsidy. In the meantime, it is best to pay the first bills yourself (they will be reimbursed later), or to contact CCSI so that we can try to block the bills.

## Health insurance: caution!

If a person calls you on the telephone or comes to your door saying you must change insurance or take on a new contract, DO NOT SIGN ANYTHING! Contact CCSI for all matters regarding your health insurance.

### **Daycare**

It is very difficult to find a place in daycare for pre-school children in Geneva. CCSI can help you increase your chances, but cannot guarantee a place. If you live or work in Geneva city, go to the Bureau d'Information de la Petite Enfance (BIPE, rue du Cendrier 8). If you live in another area in the canton of Geneva, you must go to the Secteur de la Petite Enfance of your commune - if there is one. If not, pre-register your child in the daycare center(s) closest to your home or workplace. To do so, you must present your child's insurance certificate.

CCSI can write a letter of recommendation to support your request. For this, you will need to make an appointment with the Childhood, education and health consultation at CCSI. Please note that there is no guarantee that your child will have a place in daycare. The cost of monthly payments depends on your income. There are currently no financial aids for those costs.

## Civil responsibility insurance

Civil responsibility insurance (assurance responsabilité civile or RC) covers damages caused to other people by yourself or your family (e.g. your child breaks the neighbor's window playing football, or you scratch a car in a parking lot).

This insurance is recommended for all, and is **compulsory** to register your child at daycare, for holiday camps, to rent an apartment or drive a car. It costs approximately CHF 120.- per year, and covers you and your minor children living with you. You can sign up for this insurance at any time during the year. Ask for information at your next appoint-ment at CCSI.

## Help for managing your bills

Are you having a hard time dealing with health insurance bills? Do you wonder what the difference is between a "décompte de primes" and a "justificatif de remboursement"? Do you want to know how to request reimbursement for a doctor's bill?

We offer a free and individual service to help families that are being followed by CCSI manage your child's health insurance bills. You receive many documents from the health insurance provider (policy, benefit statements, refund requests, etc.). It is very important to organize these documents properly, so as to respect payment deadlines. At CCSI, we will help you understand these various documents, and explain how to file and organize your child's health insurance bills.
